Water Truck Fill Operating Instructions:

1. First Press **RESET**.
2. Enter "1" for Upper Fill, "2" for Lower Fill, "3" for Barrel Fill. When complete press ENTER to confirm selection.
3. Enter your three-digit Access Number then press ENTER.
4. Enter your four-digit PIN then ENTER.
5. System will ask you for your desired volume. Volume is measured in cubic meters.
1 cubic meter = 1000 litres **1 cubic meter = 220 Gallons**
Enter the volume you would like to receive in cubic meters, then press ENTER.
6. System will ask you to ensure your hose is connected. Once connected, press START to begin.
7. Transaction will end automatically when desired volume has been dispensed.
8. You may press STOP at any time to stop dispensing early.

You will only be billed for water that has been dispensed.

Terms and Conditions:

- It is the responsibility of the user to immediately notify the County of Minburn Administration of a PIN# or Account Number they believe to be no longer secure.
- All bills will be issued bi-monthly. Payments are due on the 28th of each month that the invoice was issued. 1.5% penalty on balance.
- The County of Minburn reserves the right to refuse or cancel this service for any potential or current customer.
- User is responsible for all usage charges incurred on their account.
- Applicants must comply with all terms stated within the Utilities Bylaw and must adhere to truck routing when applicable (follow signage).
- Water usage is for residential or agricultural use only. **Truck fill water is not to be used for downhole oilfield usage.**
