I/We acknowledge there may be increases in the amount of the installment payment each year as a result of the County of Minburn No. 27's annual tax levy. Notification of any changes will be detailed on the property tax notice. The participant will be given 15 days notice before payment amounts are increased for any other reason. I/We acknowledge this agreement may be amended by the 15th of the month preceding the next payment date for different banking information, should the banking information supplied be directed to be changed by either me/us or our bank. Tax installment payments are non-transferable or refundable.

The Tax Installment Payment Plan (TIPP) is a monthly installment payment plan by which taxpayers may make consecutive monthly payments for taxes rather than a single annual payment.

How to Enroll for the Current Year

- Tax account must be paid in full.
- Application form must be submitted by November 30th of current year.
- If the purchaser of a property wishes to assume the existing TIPP obligations for the purchased property, they should immediately contact the Administration office. (TIPP payments are non-transferable or refundable.)

How Monthly Payments are Calculated

- Your most recent annual tax levy is divided by 12 to establish a monthly payment amount. Payments shall begin in January of the new year and continue for 12 consecutive months.
- Payment amounts will be adjusted to compensate for changes in taxes resulting from the annual tax levy. Your annual tax notice will show the total amount of installments paid to date and the calculation of the monthly installment payment for the remaining payments in that year.
- Payments may only be made by automatic withdrawal from a chequing/savings account. You must submit the Application for Tax Installment Payment Plan before the withdrawal will begin.
- If your tax installment increases for any reason other than the annual tax levy, you will be given 15 days notice before the installment amount is increased.

Withdrawal or Cancellation

- You may withdraw from the plan by submitting a cancellation form by the 15th day of the month preceding the next payment date.
- The County of Minburn No. 27 shall cancel the agreement upon default of 2 consecutive payments. All unpaid taxes become due and payable and are subject to penalties in accordance with the Tax Bylaw.

Selling Property/Change of Bank Account

- If your property is sold, title transferred, or you have a change in bank accounts, it is the responsibility of the participant to inform the Tax department in writing. We require the notice of change by the 15th of the month prior to the next TIPP withdrawal.

How to Enroll for Future Year

- Submit the Application Form with a "VOID" cheque by November 30th.
