I hereby acknowledge I am able to act on behalf of the Company noted above and request approval for this Company or its agents to request use of County of Minburn No. 27 roads. By signing this agreement the Company accepts the following conditions:

1. This agreement will be in effect from the date of authorization until December 31 of that calendar year.
2. This agreement is binding upon successors and assignees, subject to notification of any changes
3. Use legal weights only, and notify the Roadata Services Ltd. of any overweight/over dimensional loads prior to hauling. In the event that permission is requested for overload weights during Road Ban Season or for travel above a posted Road Ban limit, application may be made to post a security bond.
4. The County of Minburn No. 27 may request a security bond be provided at any time it is deemed necessary for road damages.
5. Dust control (calcium chloride or SC-250 road oil) is to be applied at a minimum of 400' in front of all residences where there is excessive ongoing road use causing dust, as determined by the Director of Operations of the County of Minburn No. 27 and must be applied within 48 hours of initial movement.
6. Any damages or excess maintenance requirements caused by trucks or equipment operating under this agreement are the responsibility of the Company. This may include but is not limited to: snow plowing, dust control, grading, re-gravelling, and/or road repair of any kind.
7. The applicant agrees to reimburse the County of Minburn No. 27 for any work deemed necessary for safe public passage as a result of this activity.
8. The applicant is to obtain all required approvals from Alberta Environment and Protected Areas, Natural Resources Conservation Board, and Alberta Transportation and Economic Corridors regarding use of the Provincial Highway System, and any other agencies to obtain any necessary approvals.
9. **The County of Minburn No. 27 is to be advised of any movement of overweight equipment on Municipal roadways by way of obtaining a permit through RoadData Services Ltd. at (888) 830-7623.**
10. **A permit is to be obtained through RoadData Services Ltd. at (888) 830-7623 for any legal loads where 2 or more loads will be moving into 1 location within 72 hours.**
11. It is the responsibility of the Company to ensure they have an approved route from the County of Minburn No. 27 for excessive or regular hauling. Once approved, a map will be provided and attached to this Agreement for the approved route.
12. The Company, its successors and assignees shall indemnify and save harmless the County of and from any and all losses, costs, charges, liabilities, damages and expenses (including without limiting the generality of the foregoing any and all liabilities to third parties, whether in contract, tort, or otherwise) which the Company at any time or times hereafter shall or may bear, suffer, sustain or incur for or by reason of the Company, its successors or assignees use of the road allowance area or by reason of the negligence of the Company, its successors and assignees servants, agents, employees or contractors.
13. In case of moving legal loads in rain or wet conditions, the applicant is responsible for any road damages.
14. In case of moving overweight/over dimensional loads in rain or wet conditions, the trucks are to be stopped immediately in order to protect the road from damage. Movement of overweight/over dimensional loads is only to take place on dry or frozen road surface.
15. All road use privileges may be suspended until such time as operations are in compliance with the above-noted conditions.
