Background:

Brock Maschmeyer is the owner of Brock Boards, a billboard advertising business started in 2018 in Bruderheim, and has since expanded to surrounding towns and cities (Redwater, Fort Saskatchewan, Lamont, Mundare, and Vegreville). Brock reached out to determine if the County would be interested in allowing him to install two billboards on property within the Town of Vegreville that is currently owned by the County.

Information for the Committee:

- SE 17-52-14-W4M (parcel of land adjacent to County Operations yard)
- Monthly rent of the billboard/sign is \$300-\$600/month
- The landowner receives a percentage of profit generated from the advertisement.
 - the County would receive 15% of the annual profit generated from the billboard ads (\$1080-\$2160/year/sign)
- Signs are 10' x 20' and illuminated by solar lighting
- No ads would be placed on the billboard that would be offensive or compete with the County's business
- Brock Boards installs, maintains, and manages the signs
 - all sign expenses are responsibility of Brock Boards
- The billboards are fully removable (no concrete used)
- Minimum contract term is 5-years
- Permitting would be required by both the Town of Vegreville and Alberta Transportation
- If approved, the County would be required to sign a 'Landowner Authorization letter' and 'Development Permit'

Recommendation:

• That Council approves administration to pursue this partnership with Brock Boards.

















Proposal Information

The County Of Minburn will receive 15% of the annual profit generated from the billboard advertisements.

Signs are double-sided which generates revenue on both sides of the sign.

The monthly rent of the billboard/side can fluctuate between \$300-\$600 per month. Creating passive income for the County of Minburn, generating a profit of \$1,080-\$2,160/year/sign.

Signs will be kept in good working condition.

No advertisement will be placed on the billboard that will be offensive or compete with the landowner's business.

No concrete will be used in the making of the billboards. The billboards are fully removable.

All expenses of the installation and construction of the sign are Brock Boards' responsibility.

The landowner will be required to sign multiple documents like the 'Landowner Authorization letter' and a 'Sign Development Permit' for the sign to be placed on their land.

Good morning Davin,

It was great speaking with you. Below I have added in information on the contract, permits, future development and the removal of the signs.

For each of my signs, I make a 5-year minimum contract. This allows me to make enough return on the sign to cover the cost of building, installing and if need be removing the sign.

If the County does develop the land we can remove the signs after the contract. The big thing about the placement of the signs is to make it so that they are in areas that will not disrupt future developments. If they end up being in an area needing to be developed they can be removed at the end of the contract or we will work something thing out if the signs need to be removed earlier than the 5 years. Placing the signs in the corners of the section allows for the best opportunity to not have to remove the signs if future developments happen.

If the county is to sell the property. The signs allow the new owner to have passive income. This creates a property that not only can be farmed or developed but also is making constant income every six months.

I will be applying for the permits with the Town of Vegreville and Alberta Transportation. The only thing I will need once our contract is signed is to have the County of Minburn sign the "sign development permit" and the "landowner authorization letter".

Thanks for reaching out through email and getting back to me so fast.

So a little information about my business, I am the owner of Brock Boards a billboard advertising business which started in 2018 in Bruderheim, AB. I worked with Patty Podoborozny to get our first three billboards installed in Bruderhiem. We have now expanded to surrounding towns and cities such as Redwater, Fort Saskatchewan, Lamont, Mundare and Vegreville

My business installs, maintains and manages signs in towns, cities and communities. We work with landowners in these communities to install larger billboards. This allows us to rent out the advertising space to local companies and businesses that do not compete with the landowner. The landowner then will receive a percentage of the profit generated from the advertisement.

Topic: 100 Year Agricultural Award Date: April 12, 2023

Background

Previous Council discussion has indicated a desire to implement a 100-Year Agricultural Award, recognizing Farm Families that have produced Agricultural products on their property for 100 years or more. A policy has been drafted and is attached to this discussion paper. The Province of Alberta has a similar recognition program where they award a large bronze plaque which can be placed in the farm home or used as a gate sign outside. Previous discussion has indicated that Council's wish was to look into having a metal sign designed that could be mounted above the Rural Address signs on the same posts.

ASB Services has contacted Hi Signs for a design, the company responsible for our rural address signs; the design is attached to the draft policy. The signs can be printed in blue, brown, and green. The quote received from Hi Signs is \$400.00 per sign.

Recommended Resolution

PURPOSE

The purpose of this policy is to recognize the significant contributions of farming/ranching families in the County of Minburn who have continuously owned and actively farmed the same land for 100 years or more.

POLICY STATEMENT

County of Minburn Council shall present the prestigious "100 Year Agricultural Award" to eligible families who have farmed or ranched in the County for 100 years or longer, and who continue to farm.

DEFINITIONS

- 1. "Council" means the duly elected Council members of the County of Minburn No. 27.
- 2. "County" means the municipality of the County of Minburn No. 27 having jurisdiction under the municipality of the *Municipal Government Act*.
- 3. "Homestead" means the residence of a person or family which comprises its home, land and surrounding property.
- 4. "Commodities" means a primary agricultural product that may be bought or sold
- 5. "100" Year Agricultural Award" refers to the award presented to those farm families who have farmed, and continue to farm, in the County of Minburn for 100 years or longer.

POLICY GUIDELINES

In order to effectively recognize the significant contributions pioneer farming families have made to the County:

- 1. The family must have continuously owned and actively operated the same land for 100 years or more.
- 2. Have a family member still actively farming the land.
- 3. The land must still be producing agricultural commodities by the owner.
- 4. The family or individual nominating the farm/ranch family must submit an application/nomination form available on the County's website at <u>www.minburncounty.ab.ca</u>

- 5. The homestead establishment date must be provided.
- 6. Historical documentation must be provided, where possible, to show ownership and support homestead establishment date.

PROCEDURE

- 1. The Agricultural & Utilities Foreman will review the application.
- 2. Administration staff will obtain and verify homestead and current land titles as supporting documentation and verification of ownership.
- 3. To mark the significant milestone, Council will present a honourary "100 Year Agricultural Award" at a County Council meeting, or at the recipient's farm or ranch as they so choose.

COMMITTEE OF THE WHOLE DISCUSSION PAPER

Topic: 2023 Final Budget Amendments/Tax Rates **Date:** April 12, 2023

Background

Council approved the 2023 preliminary budget in December 2022. Since that time there have been a number of changes due to tenders being awarded, external rates being finalized and the County is in the final stages of the land and aggregate acquisition. The attached documents summaries the changes to revenues and expenditures including reserve transfers.

Final Budget Amendments

The proposed major changes to revenue items include:

- Inflationary increase on property assessments resulted in an additional \$130k in property tax revenue above the 1% increase previously budgeted
- Doubling of the MSI operating added an additional \$150k
- Removal of the Broadband project removed \$266k of potential grant funding
- Reduction of required reserve transfers due to favourable tender results (\$135k)
- Increased draw from reserves to fund the 2 payments associated with the acquisition of land and aggregate

The proposed major changes to expenditures include:

- Increase of engineering of \$48k for gravel pit approval
- Removal of the expenses associated with the broadband project that was cancelled
- Further increases to fuel and utilities (\$195k) to offset ongoing inflationary pressures
- Addition of \$20k for strategic planning
- Addition of an additional \$20k for server room repairs and upgrades
- Adjusted the reclamation and ASB mowing service contracts to align with better than budgeted tender results
- \$3M increase to TCA for land acquisition
- \$3M increase to inventory for 2023 aggregate purchase

• Reduction of school requisition (-\$130k) for decreased school rates

Items of Note:

- The recreation agreement with the Town of Vegreville was increased to reflect a 3.3% increase that was tentatively agreed to, but this negotiation is ongoing and is subject to change.
- After the identified changes there was a \$90k surplus which was added to the Future Expenditure Reserve to arrive at a balanced budget.

Tax Rates & Minburn Special Tax

As discussed during the preliminary budget, Council endorsed a 0% tax increase for 2023 which was subsequently announced in a press release so unless Council directs otherwise, Administration is not recommending any changes to the current municipal tax rates.

The school rates are decreasing slightly which combined with the inflationary increase to property assessments means the average resident will not experience a significant change to their overall tax burden (what they will actually pay).

Example: Property valued at \$250,000 would pay \$24.98 less in school/seniors taxes but \$36.40 more in municipal taxes resulting in an increased net tax burden of only \$11.46.

In conjunction with the utility rate increases in sewer, the Minburn special tax imposed for the sewer connection will also increase by 2% from \$410 per year to \$418.20.

Recommendation

It is recommended that Council approve the budgetary amendments as presented, agree to the 2% increase on the Minburn Special Tax and the 0% tax increase on municipal rates for 2023.
